This Deed of Trust is executed at Bangalore on this, the 22<sup>th</sup> day of March 2017.

By & Between

1. **Mr. Zaid Mohammed Hussain**, aged about 36 years, S/o Mr. Maqbool Mohammed Hussain, presently residing at # No- 455, 3rd Cross, 16th Main 3rd Block, Koramangala, Bangalore - 560034, hereinafter referred to as "**Author**" or "**Settlor**" or "**President**" and **Managing Trustee** of the Trust.
2. **Mrs. Sadath Kubra**, aged about 32 years, W/o Zaid Mohammed Hussain, presently residing at residing at No-455, 3<sup>rd</sup> Cross, 16th Main 3rd Block, Koramangala, Bangalore - 560034 hereinafter referred to as a "**Secretary**" or "**Treasurer**" and "**Trustee**".

WHEREAS the aforesaid AUTHOR is desirous of creating and establishing a Public Charitable and Educational Trust under the name and style of "**GRANDEUR ACADEMIC FOUNDATION**" with the avowed objects of uplifting the socio-economic condition of the poor and downtrodden classes and inter alia setting up schools, centers or chapters and conducting demonstrations, workshops and exhibitions to popularize Education and inter alia, to inculcate, teach and for certain other public charitable purposes, wide enough for the extension of the benefits thereof to all mankind, irrespective of class, community, caste and creed and including relief of the poor and advancement of any object of general and/or public utility and so that such benefits may be given directly by the said trust to such needy and deserving persons.

Whereas the Author of the Trust has decided to endow a sum of **Rs. 5000/- (Rupees Five Thousand Only)** as the initial corpus fund and entrust the same with the Trustees for the objects hereinafter mentioned.

Now, therefore the parties hereto have framed the following scheme for constitution of the Trust and carrying out of the objects of the same:

- 1) **NAME OF THE TRUST:** The name of the trust shall be **GRANDEUR ACADEMIC FOUNDATION.**
- 2) **OFFICE:** The Principal Place of the Trust shall be at No- 455, 3rd Cross, 16th Main 3rd Block, Koramangala, Bangalore – 560034, Karnataka, India and this may be changed as and when necessary as per the decision of the majority of the Trustees.


The Jurisdiction of the Trust shall be limited to the Geographical territory of the Republic of India.

- 3) **TRUSTEES** mean and include the Board of Trustees as described in these presents, and other Trustees appointed, nominated or selected by the majority members of the Board of Trustees from time to time.

4) **OBJECTS OF THE TRUST:**

The main Objects of the Trust shall be as follows:

- (1) To promote and popularize the Education in India Only.
- (2) To promote education of all types and grades among the people of the country in general and among the downtrodden communities in particular with a view to accelerate the liquidation of ignorance, superstition and illiteracy by establishing schools, Educational Institutions and Centers .The term "downtrodden Community" shall mean and include people of all sections of the Nation who are educationally, socially and economically downtrodden.
- (3) To run, set up, and manage the School(s) under the name and style of "Grandeur International School" and/or in any name(s) as decided by the Trust from time to time.
- (4) To award scholarships for deserving students for all type of financial helps like to payout their tuition fees, examinations fees, boarding and lodging fees, to supply books and other resources for education at a subsidized cost or free of cost to such students.

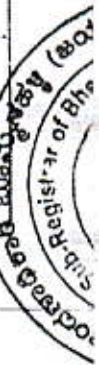

- (5) To make monthly or other periodical or lump-sum grants and contributions for the advancement of education to educational institutions.
- (6) To render financial help to deserving students to enable them to pay fees, purchase books and other equipment's necessary for their education.
- (7) To create awareness of education among the society and organize and conduct seminars, Classes, Programs, Serials and Advertisement through Electronic Media such as Television Channels, Radio Broadcastings, Internet, etc., to publish articles, advertisement etc., in print media such as Newspapers, Magazines, Souvenirs, websites, etc.,
- (8) To promote education of all types in general and technical education in particular, among the educationally, socially and economically downtrodden communities in India only.
- (9) To take steps to disseminate scientific, technical and cultural knowledge and training among the people.
- (10) To strive by all legitimate ways and means to secure the cultural, social and economic welfare of the people in general and of the downtrodden classes in particular.
- (11) To start libraries, reading rooms and cultural centers and community halls.
- (12) To establish and run Industrial Training Institutes, Schools, Research Institutes etc.
- (13) To arrange for distribution and assist in publication of books on culture and literature, without any discrimination on the grounds of religion, sect. Caste or creed etc.
- (14) To strive in legitimate ways and means to secure the cultural, social and economic welfare of the people in general and of the downtrodden classes in particular.
- (15) To establish and run boys and girls Home separately for Orphans and destitute;
- (16) To establish & manage schools, colleges, polytechnics and other educational or industrial institutions for boys and girls separately at various centers and also to extend aid to such institutions.
- (17) To take over the management and maintenance of schools, colleges, polytechnics and other educational or industrial institutions which are maintained and managed by other authorities and organizations by mutual agreement.

- (18) To associate, cooperate or collaborate with, assist and help any other organization having objects and aims similar or akin to the objects and aims of the Foundation in appropriate ways.
- (19) To affiliate with other organizations having objects and aims similar or akin to the objects and aims of the Foundation.
- (20) To render financial help to deserving students to enable them to purchase books and other equipment necessary for their education.
- (21) To provide financial assistance for deserving students for higher studies;
- (22) To organize Awareness programs on Health, Social, Political, Legal and schemes available for the benefit of society from government and non-government undertakings.
- (23) To organize social awareness programs for the betterment of the people in general like alcoholism, drug addiction, tobacco consumption, devadasi system, child marriage, legal aid programmers, child and women welfare, social forestry program, solid waste management awareness program, consumer awareness program, safe drinking water awareness, micro finance schemes awareness, safe driving program, child labour program, etc.,
- (24) To start, run and manage hospitals of all types, health care centers, dispensaries, family welfare centers, maternity and child welfare centers and medical awareness camp in rural and urban areas.
- (25) To run special programs on nutritional awareness for children and adults, family planning awareness, HIV & AIDS, health counseling, polio eradication, cancer awareness and to take up government health projects.
- (26) To open blood banks & ambulance facilities in rural & urban areas.
- (27) To assist poor and downtrodden classes of people in medical treatment, natural calamities, water shed development, drinking water, waste land development program etc.
- (28) To establish projects for the improvement of the economic conditions of the women in India without any distinction of caste and to setup a separate wing for women empowerment and conduct leadership training program for women and establish Mahilaya Swayam- Sahaya Groups (Women self-help groups).

- (29) To conduct, arrange or assist for group/mass marriages for the poor and deserving people in the society and to assist and provide festival kits, educational kits, health kits, etc to the poor and needy people in the society.
- (30) To assist and generate employment opportunities in the society.
- (31) To do all other acts, deeds or things which are incidental, ancillary or conducive to the fulfillment of any or all of the above objects and aims of the Foundation.
- (32) It is open to the Trustees to add to, modify, or supplement the objects of the Trust, provided, however, they shall be charitable in nature and be within the ambit of the objects for which the trust is established viz., for the charitable purpose defined in the Income Tax Act, 1961.

The activities would purely be of Charitable Nature and not motivated for profit. The funds of the Trust would be utilized only towards the objects and no portion of this fund would be distributed in any manner to the Trustees or persons as defined in Section 13(1)(c) and the funds shall be invested as per Section 11(5) of the Income Tax Act 1961.

5) **CORPUS FUND:**

- i) The corpus of the Trust shall be Rs. 5,000/- (**Rupees Five Thousand only**) contributed by the Author and vested with the Board as Corpus and any other sum that may be received from time to time towards the corpus.
- ii) Contributions can be collected from time to time and added to the Trust's corpus from any individual, group of individuals and other institutions, whether incorporated or not, and such contributions shall also form part of the corpus or nucleus of the Trust, Provided that only the members of the Board, or the persons specifically authorized by the Board, shall be competent to collect donations on behalf of the Trust.
- iii) Provided further that the Trust's official receipt shall be issued forthwith for every donation received, irrespective of the amount donated and any such receipt shall be issued only by the President/Vice President/Managing Trustee/Secretary or anyone else specifically authorized by the Board.

**6) BENEFICIARIES:**

The Benefits of the Trust shall be to one and all. The general public, the poor and needy, deserving, orphans, widows, economically downtrodden of all communities, irrespective of cast, creed and religion will form the non-exhaustive list of beneficiaries.

**All the activities shall be confined only to the Geographical territory of Republic of India.**

**7) TRUSTEES:**

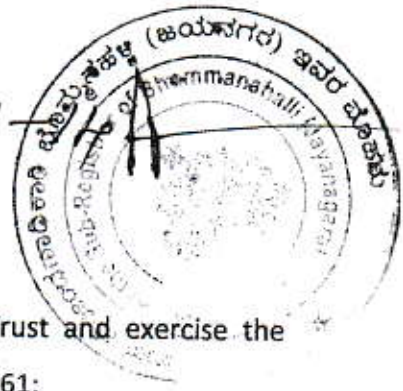
- a) The number of the Trustees shall be not less than two and not more than the number deemed fit, as decided by the majority of the trustees from time to time.
- b) The below named persons will be the First Trustees of the Trust and constituted as board of Trustees and they shall continue as Trustees for their lifetime or until they submit their resignations or are disqualified to serve in the office of Board of Trustees by a unanimous vote.

- c) All the Trustees other than the First Trustees shall hold office for a period of 2 years and are eligible for reappointment for further period of two years.
- d) In the event of death or unwillingness of any of the Trustees to continue in the Trust herein, the remaining Trustees may appoint/co-opt/elect/any willing person(s) as Trustee(s). Any such Trustee(s) shall have all powers of the Trustee(s) appointed herein. The appointment of the Trustees shall be by majority.
- e) Every Trustee will be at liberty to resign on giving one month notice of his intention to do so. The Board shall have the power to remove a person from the Trusteeship by a majority decision without assigning any reason.

**8) POWERS OF TRUSTEES:**

The Board of Trustees shall have the control and management of the Trust and exercise the following powers within the ambit of the provisions of the Income Tax Act, 1961:

- a) To determine from time to time to commence and to take up the object and purposes for which the funds of the trust shall be used and allot and allocate to each of the objects such portion of the funds as they deem fit.
- b) To purchase and acquire of any immovable property of any kind for this object of the Trust or as a source of income for the Trust shall be done only after prior approval from the board of trustees.
- c) To sell, mortgage, or dispose of any immovable property/properties belonging to the Trust shall be done only after prior approval from the board of trustees.
- d) To incur all expenditure necessary as in their own opinion useful for carrying out the objects and administration of the trust;
- e) To open one or more bank accounts of the trust with any bank or banks as the Trustees may deem fit and deposit monies of the Trust in the Bank accounts.
- f) To borrow for and on behalf of the Trust with or without security from banks, Governments, Universities or any other government Body/bodies both central and state.
- g) To employ staff of all kinds necessary and useful for carrying out the objects of the trust.
- h) To incur such other items of expenditure as is necessary and incidental for carrying out the objects of the Trust.
- i) To institute, conduct, defend, compound, withdraw, compromise, adjust, refer to arbitration or to do such things as are incidental and necessary, concerning the affairs of the Trust and to sign and verify vakalats, pleadings, affidavits and other allied powers.
- j) To delegate all or any of the powers vested in the Trustees to anybody' to frame rules, bylaws and other codes for the conduct of the affairs of the Trust and its transactions and establishing any Committee.
- k) To accept contributions in cash or in kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the Trust.



1) To establish as many adhoc committees' for any purpose.

**9) BANK ACCOUNT:**

All the money should be received only on account of and in the name of the Trust and must be signed by Author/President/Secretary/Treasurer or by the authorized person. The Treasurer shall be personally responsible for full and complete accounting of all the receipts and disbursements of the monies received for the Trust. The money shall be deposited in a scheduled bank and shall be operated jointly/singly by the President and/or Secretary/Treasurer.

The Bank Accounts of the TRUST shall be opened and maintained in the name of the Trust and shall also be opened and maintained in the name of any institutions setup by the trust for furthering the aforementioned objectives.

Specifically, Bank accounts shall be opened in the names of:

- a. Grandeur Academic Foundation
- b. Grandeur International School

**10) ACCOUNTS AND AUDIT:**

The financial year of the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of the succeeding year. The accounts of the Trust shall be audited annually by a Chartered Accountant to be appointed by the Board.

**11) SUITS AND LEGAL PROCEEDINGS:**

The Board may appoint Legal Advisor to seek and assist the Board in legal matters.

**12) DISSOLUTION/WINDING-UP OF THE TRUST:**

The Trust is irrevocable. It shall have powers to wind up the Trust activities, the property, funds and assets of the Trust that may remain after full satisfaction of liabilities of the Trust, will be transferred, paid and handed over to any other Trust, Society or institution established for achieving similar aims and objectives and enjoying exemption u/s 12AA and U/s 80G of the Income Tax Act, 1961 provided that

(a) Notice of such meeting is served on all the trustees as on that date.

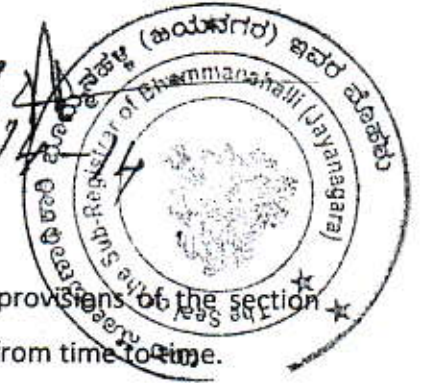
- (b) Such meeting is attended by not less than 75 % of the trustees.
- (c) Such decision or resolution is carried by the votes of at least 2/3 of the trustees present.
- (d) At the time of this special meeting, all Trustees shall exist in office and there should be no vacancy existing on the Board.

**13) AUTHORISED REPRESENTATION:**

The President and/or the Author/Settlor or the Secretary is authorized to represent and sign all documents and papers in connection with the transactions under taken by the Trust to various Central / State Govt. Departments or any other such Legal Bodies and to appear in Court and other Statutory Authorities, on behalf of the Trust.

**14) AMENDMENTS:**

- (a) If any amendments are necessary to attain the object of the trust, then the Author has his discretionary power/right to amend, modify, add or cancel any provisions mentioned hereinabove during his lifetime even without the consent of the then trustees.
- (b) In the case of other than the above (a), if at any time it is found that alterations in any of the provisions of the Trust for the purpose of effective achievements of the objects of Trust are imperative and essential, then the Board of trustees shall approve of such alteration by resolution passed in its meeting provided that such rules and bye-laws shall not be inconsistent with or repugnant to any of the provisions of the scheme of the Trust, and thereafter the modification shall become part and parcel of the term, conditions and provisions of the Trust.
- (c) In the case of situation as stipulated in the above (b), no amendment, alteration, deletion or addition to the claims and objects or rules and regulations of the Trust shall be carried except with the approval of two-third majority of the existing Trustees.
- (d) However, any amendment shall be carried out only with the approval of Commissioner of income- Tax (Exemptions), Bangalore.



**15) INVESTMENT CLAUSE:**

The funds of this trust shall be invested in modes specified under the provisions of the section 13(1)(d) read with section 11(5) of the Income Tax Act, 1961, as amended from time to time.

**16) UTILISATION CLAUSE:**

The funds and the income of the Trust shall be solely utilized for achievement of the objects of the Trust and no payments shall be made to the Trustee by way of profit, interest, dividends etc.

**17) DECLARATION:**

This Trust and the scheme set forth under this indenture shall come into force immediately after the execution and registration thereof.

The Trustees above named also hereby declare that they have consented to be the Trustees under this Trust, accepted the Trust and have taken delivery of the possession de'jure and de'facto of the scheduled fund.

There is no movable (except corpus fund in cash) or immovable property at the time of registration of this trust.
